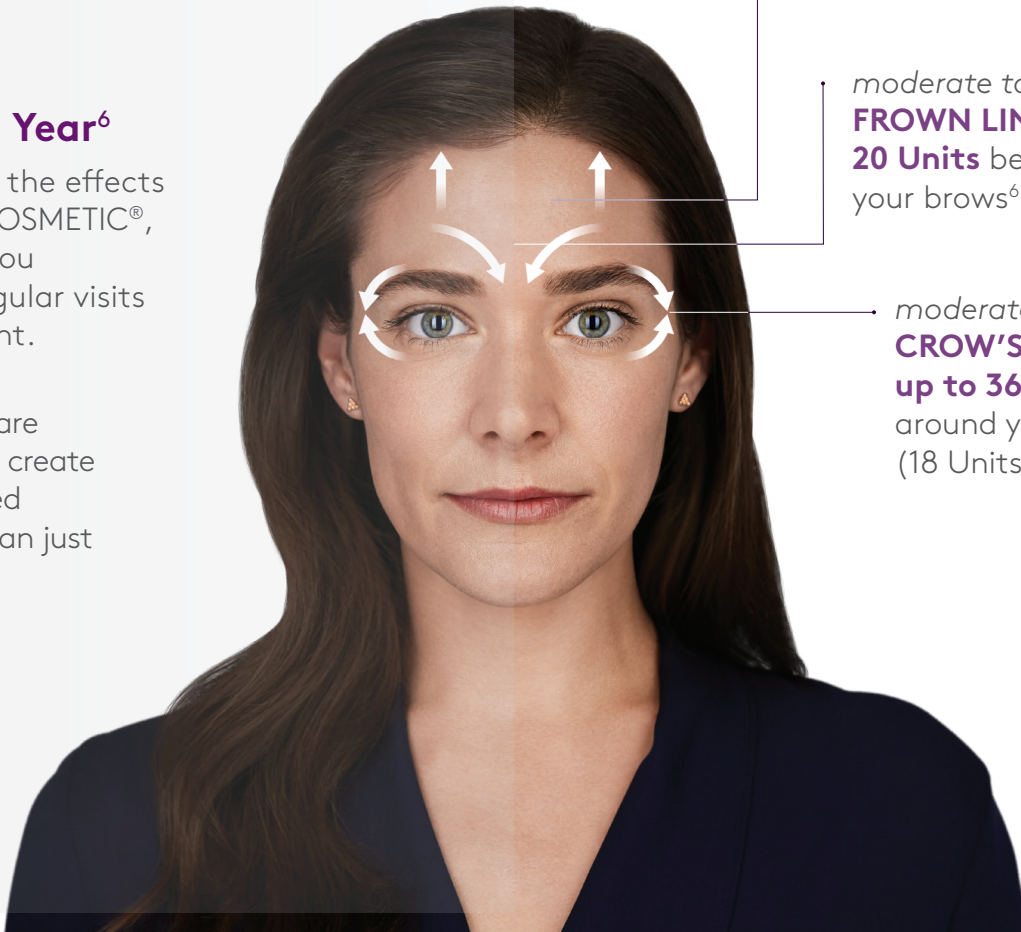

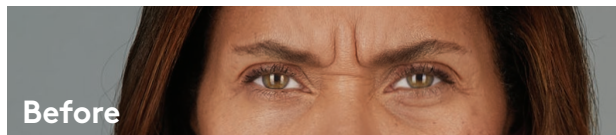

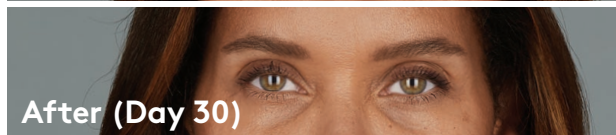

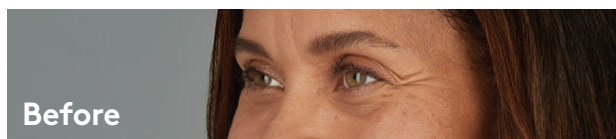

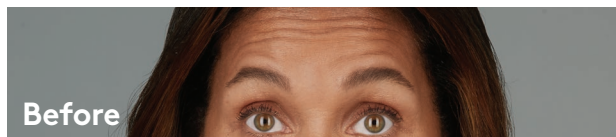

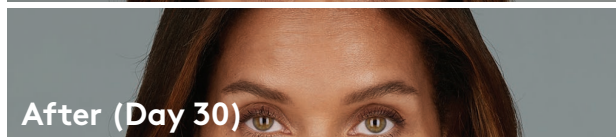

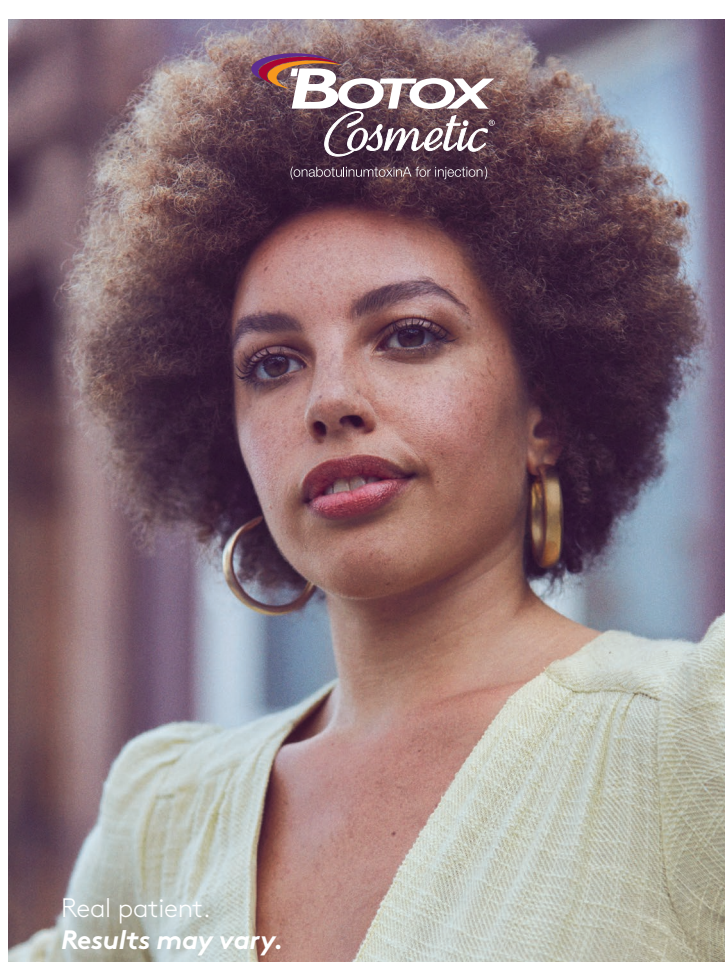

WHAT TO EXPECT

What is treatment like?

A BOTOX COSMETIC[®] treatment is quick and simple, with no downtime. After meeting with your healthcare professional to determine your desired outcome, the procedure itself takes only 10 to 15 minutes. A tiny amount of BOTOX COSMETIC[®] is injected with a fine needle into the muscle being treated—this process is virtually painless.^{6,10}

Will my face still show emotions and expressions?

BOTOX COSMETIC[®] is intended to enhance your look, not change it—you can still smile, frown and be expressive.^{6,11-12}

When will I see results and how long will they last?

You'll begin to see results as soon as 24 hours after your treatment, and the lines may continue to fade up to one week afterwards.⁸ The effects can last up to four months.⁹

How often will I need to get BOTOX COSMETIC[®]?

Expect to come back at least 3 times a year. It's important to space out your treatments – at least 90 days apart.⁶ Since the BOTOX COSMETIC[®] effect is temporary, you'll need to be consistent with scheduling your next assessment.

Are there any do's or don'ts I should follow after a BOTOX COSMETIC® treatment?

- Avoid rubbing or massaging the treated areas for 24 hours after treatment
- Cleanse your face gently that evening (do not rub)
- Avoid make-up application for 4 hours following treatment
- Avoid excessive bending down, tiring physical exercise, or hot tub use on the day of treatment

What are the possible side effects associated with treatment?

The side effects can be pain, tenderness and/or bruising at the site of injection, as well as generally feeling unwell, lasting up to 6 weeks after the treatment. There may also be weakness and rarely, changes in the way the heart beats, chest pain, skin rash and allergic reaction including shortness of breath, wheezing or difficulty breathing; or swelling of the face, lips or tongue or other parts of the body; rash, itching, or hives on the skin.⁶

Seek immediate medical attention if swallowing, speech or respiratory problems arise. Tell your doctor if you experience any difficulties in swallowing food while on BOTOX COSMETIC®, as it could be related to the dosage. BOTOX COSMETIC® SAFETY INFORMATION⁶

BOTOX COSMETIC® is used to treat upper facial lines, including forehead, crow's feet and frown lines.

BOTOX COSMETIC® is onabotulinumtoxinA, a sterile, purified form of botulinum toxin type A. BOTOX COSMETIC® should only be given by a physician with the appropriate qualifications and experience.

You should not use BOTOX COSMETIC® if:

- You are allergic or sensitive to any of the ingredients
- You have an infection in the area where it would be injected
- You have myasthenia gravis, Eaton Lambert Syndrome, amyotrophic lateral sclerosis, peripheral motor neuropathic disease, or neuromuscular junction disorder

Before you receive BOTOX COSMETIC® talk to your doctor or pharmacist if:

- You are scheduled to have surgery using a general anaesthetic
- You are taking or are likely to take antibiotics, especially aminoglycoside antibiotics as they may increase the effect of BOTOX COSMETIC®
- You are pregnant or become pregnant or are nursing while taking this drug

Tell your doctor if you are taking other medicines, including any you have bought at your pharmacy, supermarket or health food shop.

General side effects of BOTOX COSMETIC® injections include pain, tenderness and/or bruising at the site of injection, weakness and malaise (generally feeling unwell). There have been rare reports (<0.1%) of changes in the way the heart beats, chest pain, myocardial infarction (some with fatal outcomes); skin rash; allergic reaction (symptoms: shortness of breath, wheezing or difficulty breathing; swelling of the face, lips, tongue or other parts of the body; rash, itching or hives on the skin); facial paralysis; seizures; or difficulty swallowing. Seek immediate care if swallowing, speech or respiratory problems arise.
